**Explanation of Responses:**

- On January 4, 2023, the reporting person was granted 27,044 Restricted Share Units ("RSUs"). On redemption, 9,331 RSUs were withheld by the Company solely for the purpose of satisfying tax withholding obligations and the reporting person received 17,713 common shares.
- The common shares were priced at \$1.61 Canadian dollars and \$1.1154 U.S. dollars is the equivalent of the purchase price pursuant to the exchange rate as of the transaction date (Cdn\$1.00 = US\$0.6928) as reported by Bank of Canada on its website, www.bankofcanada.ca.
- Each RSU is redeemable upon vesting for one common share
- The RSUs became redeemable on January 4, 2025 and were released on January 17, 2025.
